- **Gift from a tax deferred account**  
Designate LTEF fund as a beneficiary of your IRA, 401K, 403B or annuity
- **Gift from Life Insurance**  
Designate LTEF fund as a beneficiary
- **Life Income Agreement**  
Make a monetary gift or make a gift of securities or real estate into a life income agreement such as a gift of annuity or charitable trust.

## LTEF Endowment Fund

This fund will receive gifts and bequests  
designated as a mission grant endowment.  
These endowment gifts and bequests will  
be pooled and invested to perpetually  
produce income. The income, but not the  
principal, will be used for mission grants  
recommended by the committee to the  
LWML IWD Executive Committee and  
Board of Directors with approval by simple  
majority of the board.

## LTEF Legacy Fund

This fund will receive gifts and bequests  
designated for mission grants. These gifts  
and bequests shall be pooled and  
invested to produce income. The principal  
and any income generated will be used  
for mission grants. The distribution of  
these funds will be for mission grants  
recommended by the committee to the  
LWML IWD Executive Committee and  
Board of the Directors with approval by  
a simple majority of the board.

The LWML Iowa West District has  
established the Light That Endures Fund  
to receive gifts of money and property,  
either directly or through bequests  
under wills or trusts, to further the  
Lord's work of sharing the Gospel.

Contributions may be made as  
a memorial or to honor special  
occasions such as birthdays,  
anniversaries, graduations, etc.
